UNOFFICIAL TRANSLATION

Regional provisions for the promotion and enhancement of the
Journeys of Memory

Approved on May 17, 2022
In force since May 26, 2022

Art. 1**(Purpose and Object)**

1. The Region pursues the affirmation of the universal values of freedom, equality and democracy, and supports peace, the repudiation of war, as well as the rejection of authoritarianism and totalitarianism, both directly and by promoting collaboration with schools, local authorities and associations and non-profit organizations, also through the preservation and education of the memory of the new generations.

2. For the purposes referred to in paragraph 1, this law contains provisions on the promotion and enhancement of "Journeys of Memory", such as experiences aimed at impressing the value of memory of the dramatic events linked to the history of the twentieth century in the consciences of new generations.

Art. 2**(Definitions)**

1. For the purposes of this law, the following definitions apply:

- a) Journey of Memory: visit in person or in virtual mode, during the school year, to one or more places of Memory of the regional, national and foreign territory by students and teaching staff of primary schools, secondary schools of first and second level or of the institutes of Vocational Education and Training (IeFP) aimed at:
 - 1) preserve and transmit to the new generations the Memory of the dramatic events linked to the history of the twentieth century;
 - 2) enhance the role and activity of places of Memory;
 - 3) strengthen the tools aimed at study and training;
 - 4) to promote reflection on the current significance of the dramatic events of the twentieth century to learn from them and encourage the participation of citizens in democratic life, as well as to combat denial and all forms of prejudice, racism, xenophobia and violence;
- b) Place of Memory: area of the Italian or foreign territory, where historical events related to the dramatic events of the twentieth century or in any case evocative of the same took place.

Art. 3**(Beneficiaries of contributions)**

1. In implementation of the purposes referred to in Article 1, the Region grants financial contributions aimed at supporting, by means of a shared cost, the organization of the Journeys of Memory.

2. The following subjects may access the contributions referred to in paragraph 1, upon presentation of a Memory Journey project:

- a) primary schools, first and second level state and equal secondary schools and Vocational Education and Training institutes (IeFP);
- b) local authorities;

c) other bodies, associations and non-profit organizations operating on the territory of the region.

3. The subjects referred to in letters b) and c) of paragraph 2 may request the contributions referred to in this article only upon presentation of a Memory Journey project, developed jointly with one or more schools or institutes referred to under letter a) of the same paragraph.

Art. 4

(Criteria and methods of disbursement of contributions)

1. The Regional Government defines, after obtaining the opinion of the competent Regional Council Commission, the methods of implementation of this law and in particular the criteria for evaluating the projects referred to in Article 3, paragraph 2, which take into account the number of schools and students involved in the project, with priority for the schools and institutions involved for the first time, of sharing the project with the subjects referred to in letters b) and c) of paragraph 2, of article 3, as well as the production of preparatory and in-depth material suitable for online distribution.

2. The Regional Government, for the purpose of disbursement of the contributions referred to in Article 3, paragraph 1, issues an annual call, in which the subjects referred to in Article 3, paragraph 2 may participate; in the event of participation in an associated form, the Journey of Memory project is proposed by a lead partner.

Art. 5

(Fundings)

1. The expenses for the contributions referred to in article 3, paragraph 1, of this law, foreseen in euro 200,000.00 for each year of the three-year period 2022-2024, will be provided with an increase of euro 200,000.00 for each year of the three-year period 2022-2024 of mission 04 "Education and right to study", program 06 "Auxiliary services to education" - Title 1 "Current expenses" and corresponding reduction, for the same amounts and financial years, of mission 20 "Funds and provisions", program 03 "Other Funds" - Title 1 "Current expenditure" of the estimate of the expenditure of the budget 2022-2024.

2. For the financial years subsequent to 2024, the law approving the financial statements of the individual financial years will be adopted.
