The General secretariat of the CALRE has been seized of a request from the President of the Consiglio regionale del Molise (Italy) aiming to obtain the patronage of the CALRE for an event within the framework of the European Year of Youth. Concretely, it is requested that the CALRE logo be affixed to the communication media of the event which is taking place on 15 July.

Since this is a precedent, President Marcourt wishes to submit the following proposal to you:

- creation of a specific logo "With the support of the CALRE" (a version in each official language of the CALRE with also the mention in English; see attachment);
- when an action is organised by a member assembly, possibility for the latter to use the logo without the need for authorisation from the Standing committee;
- when an action is organised by an organisation other than a member assembly, submission of the request to the Standing committee (member states representatives).

Can you let me know your feelings about this proposal by 17:00 CET today so that the President of the Consiglio regionale del Molise can be provided with the decision of the Standing committee?

A feedback on the proposals for translations by the correspondents would also be welcomed.
